### 2018 Enrolment Fees - Dee Why Campus

<b>Application Fee</b>	\$220	Payable when lodging the Application to Enrol form. The Application Fee (which is non-refundable and inclusive of GST) is payable by credit card, cheque or cash, directly to the School.
<b>Acceptance Fee</b>	<b>Junior</b> \$1500	Payable when accepting an Offer of Enrolment. The Acceptance Fee (which is non-refundable) is payable by credit card, cheque or cash, directly to the School.
	<b>Senior</b> \$2000	The School's receipt of the 'Offer of a Place' letter, signed and returned by parents together with payment of the Acceptance Fee, constitutes acceptance of the place offered.

#### Notes

- The Schedule of Fees & Charges is set each year by the School Council and may vary from time to time by written advice.
- The Service Charge is a combined charge for stationery, technology/resources, School Annual, School Diary, whole grade/year excursions & incursions, PDHPE / Sport fees and Camps for all students.
- Additional Charges will appear when optional activities such as Basketball, Band and VETB Courses etc are participated in.
- This Schedule of Fees & Charges does not apply to International Students. A separate Schedule for International Students is available from the School Office.
- In cases where a student commenced prior to this year, there may be variances in Enrolment Fees paid, and the Terms & Conditions of Enrolment with regards to the treatment of the Bond or Acceptance Fees paid at the time of initial commencement.

### Family Allowance

A concession in School Fees is allowable where two or more members of the immediate family concurrently attend the School (Dee Why or Bayview Campuses) and where no other concession applies, eg, a scholarship. The concession is not open to students placed by corporate debtors. The Family Allowance is for School Fees and does not extend to Service Charges.

### Payment of Fees & Charges

The Parents are to pay all Fees & Charges in advance, at the end of the first week of each term, except Fees & Charges on amended accounts and accounts raised for mid-term enrolments, which the Parents are to pay within seven days from the date of the invoice.

There are several options available for payment of Fees and Charges. These include:

1. Online - Log into the Parent Portal (<https://edumate.stlukes.nsw.edu.au>) and access Payment Options by Direct Debit or Credit Card. (Visa, Mastercard or American Express - A 1% surcharge applies to Credit Card transactions.)
2. BPAY® (including Debit or Credit Card linked to bank account)
3. Cheque or Money Order at the commencement of each term
4. The entire year's fee at the commencement of the year

If the Parents fail to pay an account for Fees and Charges within 21 days of the due date they will be liable to pay an overdue charge which reflects the administrative and financial cost to the Corporation in collecting the outstanding Fees and Charges. The Parents may enquire as to the current amount of the overdue charge at the Group Office of the Corporation.

If an account for Fees and Charges is not paid in full within 60 days from its due date, the Student's enrolment may be suspended and the Principal may without further notice refuse entry to the Student and/or terminate the Student's enrolment.

### Voluntary Contributions - Building Fund ABN 63 544 529 806

The Building Fund assists financially with acquiring, constructing and maintaining school buildings. The future development of the school is supported by the Building Fund. Voluntary donations to the Building Fund are tax deductible for amounts of \$2 or more. An amount of \$250 per term is the suggested contribution from each family.

### Withdrawal of Student

The Parents of both Junior and Senior School Students, at either the Dee Why or Bayview Campuses, are to give at least one full term's notice in writing to the Principal, Mrs Jann Robinson ([principal@stlukes.nsw.edu.au](mailto:principal@stlukes.nsw.edu.au)) before terminating the Student's enrolment. If the Parents do not give sufficient notice of termination of the Student's enrolment, they are to pay to the School one term's School Fees, plus GST as applicable. The Parents agree that this amount is a genuine estimate by the School of the loss that it would suffer as a consequence of insufficient notice of termination of the Student's enrolment.
