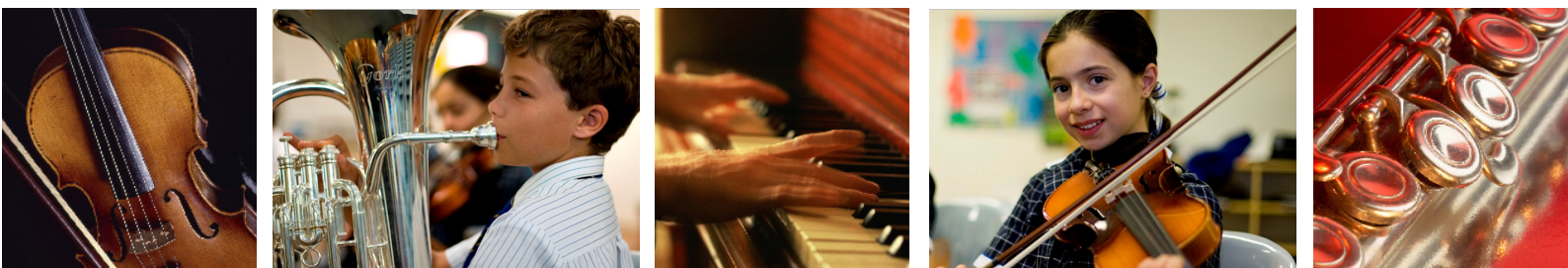

# Music Scholarships



Online Registration closes **Sunday 7 March, 2021**  
Performance Recordings to be submitted by **Friday 19 March, 2021**



All registrations for Music Scholarship are to be completed ONLINE.

1. Music Scholarships are offered for Year 7 entry [for Years 7-12] and/or Year 11 entry [for Years 11-12]
2. Music Scholarships are available to both existing St Luke's students and those not currently enrolled.
3. Scholarships are awarded on the basis of performance in the Recording and at the Audition, and through experience, determined by documentation received such as AMEB Grade results etc and Interview.
4. Scholarships include remission of Tuition Fees ranging from 25% to 100% and are tenable to Year 12. All other expenses are to be met at the full rate. Scholarship recipients will have their progress reviewed each year.
5. The Music Scholarship process contains 3 stages:
  - **Stage 1:** Applicants are to submit a DVD (or USB) recording by **FRIDAY 19 MARCH, 2021**. The performance is to be a minimum of 2 contrasting pieces, with the combined total performance time being no longer than 10 minutes. The applicant may choose to demonstrate one or more instruments. Accompaniment is not necessary.
  - **Stage 2:** The top performing students will then be invited to attend a live Audition during Term 2 2021, **date to be confirmed**, where they will be required to play a third piece on their principal instrument. The Audition will also include a short Interview with the Audition Panel, and a sight reading exercise. Applicants should also bring a Portfolio outlining their Musical (and other) experience and accomplishments and other documents they feel relevant.
  - **Stage 3:** Short Listed applicants will then be invited to participate in an Interview with the Principal. Subject to a successful Interview, Music Scholarships may then be awarded.
6. Candidates should be at least 4th Grade AMEB standard or similar.
7. Students who receive Music Scholarships will be required to be involved in the School's Music Program. The extent of the involvement will be established in consultation with the Head of Performing Arts at the commencement of the student's Music Scholarship and reviewed at the beginning of each subsequent year.
8. The Scholarship will be awarded subject to satisfactory school progress to date, and will be reviewed annually. It is expected that the successful candidate will display acceptable levels of classroom behaviour and progress.
9. The School reserves the right to make no Award.
10. Where the Student is eligible for more than one rebate of fees only the greater of the two applies.
11. Invitations to the live Audition (top performing students) will be sent approximately 2 - 3 weeks prior to the Audition.
12. **The closing date for all online registration is Sunday 7 March 2021.**
